General Information:

1. This is for students enrolled in units STA70003, STA70004, STA70005 or STA80005 in SP1 or SP3 2017.
2. In the form below, for those who do not have SAS installed, please tick “Full Installer” or If you have an expired license, please tick “License Renewal”.

Technical Information:

SAS 9.4 can ONLY be installed on the following Windows editions:

- **Microsoft Windows 7 SP1 - Pro, Enterprise and Ultimate Editions**
 - **Microsoft Windows 8 - Pro, Enterprise**
 - **Microsoft Windows 8.1 – Pro, Enterprise**
 - **Microsoft Windows 10 - Home, Pro, Enterprise, Education**
1. The above editions are available in 32bit or 64 bit.
 2. 64-bit versions are preferred as they can address & use large amounts of RAM (up to 192 GB).
 3. 32-bit versions can only address and utilise 4GB of RAM (even if you have more RAM installed), which is insufficient to handle large datasets.
 4. **SAS does not run on MAC operating systems.** You will have to install a windows emulator, such as Boot camp (see <http://www.wikihow.com/Emulate-Windows-on-a-Mac>) and boot into one of the required windows operating systems. There are several emulators available, however, please note that none of these are supported by Swinburne IT or staff at Swinburne, and the ability to run SAS9.4 has not been determined.
